- Bishnupur Rural Municipality, Saptari has allocated funds or received a loan/credit/grant from [GoN]
 towards the cost of Construction / Upgrading of Parsahi Thalahi Road & Drain and intends to apply
 part of the funds to cover eligible payments under the Contract for [Construction / Upgrading of
 Parsahi Thalahi Road & Drain, Contract ID: NCB/SK/03/2079/80]. Bidding is open to all eligible
 as per Section V of bidding document.
- Bishnupur Rural Municipality Saptari invites sealed bids or electronic bids from eligible bidders
 for the construction of Construction / Upgrading of Parsahi Thalahi Road & Drain, Contract ID

 NCB/01/2079/80 under National Competitive Bidding Single Stage Two Envelope Bidding
 procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: NRs 31.60million.
- Minimum Work experience of road project of similar size and nature: at least one road project with value NRs. 15.00 million.
- 3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
- Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of Bishnupur Rural Municipality, Saptari or may visit PPMO e-GP system www.bolpatra.gov.np/egp.
- 5. A complete set of Bidding Documents may be purchased from the office Bishnupur Rural Municipality, Saptari by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of Nrs. 5000.00 till 15 December 2022 during office hours. Or
 - Bidder to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document in the Project's Rajaswa (revenue) account as specified below.

- Pre-bid meeting shall be held at Office of Rural Municipal Executive, Bishnupur, Saptari at 13:00, 30 Nov 2022.
- Only electronic bids must be submitted to the office Bishnupur Rural Municipality, Saptari through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12:00 on 15 Dec 2022. Bids received after this deadline will be rejected.
- 8. The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00, 16 Dec 2022 at the office of Bishnupur Rural Municipality, Saptari. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of Nrs. 8,85,000.00, which shall be valid for 30 days beyond the validity period of the bid. (i.e.90/120 days)
- 9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
